

AGREEMENT FOR STUD SERVICE

It is hereby agreed and accepted that

A Stud Fee Rs. _____ has been paid in full by the Owner of the Bitch to the Owner of the Dog on _____, receipt of which the Owner of the Dog hereby acknowledges.

The Owner of the Dog has given to the Owner of the Bitch full particulars of the Dog, including inspection of the original INKC Reg. Certificate & Pedigree, which is to the satisfaction of the Owner of the Bitch

*In case of **unproven Sire**, full Stud Fee is to be refunded if the bitch does not conceive, provided the Owner of the Bitch (Breeder) so informs the Owner of the Dog (Male) in proper time, and gives full opportunity to the Owner of the Dog (Male) to inspect the Bitch and ascertain that she has not conceived.*

*In case of a **proven Sire**, i.e. a dog having at least one of its progeny registered, free service shall be given to the same Bitch within a year, by the same Dog.*

B Pick of Litter In lieu of Stud Fee, one puppy will be chosen by the Owner of the Dog when the litter is 4 weeks old, and taken possession of between 6 to 8 weeks.

It is the duty of the Breeder (Owner of the Bitch) to ensure the health and well-being of the puppy selected by the Owner of the Dog, and hand it over to the Owner of the Dog in sound health and good condition. Should the selected puppy die or be injured or become ill before the Owner of the Male takes possession of it in the stipulated period, the Breeder shall – at the option of the Owner of the Male – offer one of the remaining puppies, or the reasonable price in cash of one puppy.

If, however, only one puppy survives to 4 weeks, the sum of Rs. _____ will be paid as Stud Fee in full and final discharge of this Agreement.

If the bitch does not conceive, or there is no surviving puppy 4 weeks after whelping, no payment or further service will be due.

Reasonable opportunity should be given to the Stud owner or his representative to inspect the bitch and the litter at any time, and choose his pup before any puppy is booked.

For either A or B, Owner of the Dog shall counter-sign the Breeder's Application for Registration of Litter ONLY AFTER inspecting the Litter and ascertaining the details provided by the Breeder, and NOT at this stage.
